

### Voting Early by Absentee Ballot

No excuse is needed. Voters are encouraged to vote before Election Day by absentee ballot.

### Absentee Ballot Applications

If you voted in recent elections, you may receive your application in the mail. Complete the application and either drop it off or mail it to your local Clerk's office at your earliest convenience.

If you haven't received your application, visit [www.Michigan.gov/vote](http://www.Michigan.gov/vote) to either apply online for an absentee ballot or download an application and return it to your local Clerk by October 19. Or visit your local Clerk's office to apply in person.

### Voting Absentee in the Clerk's Office -

For 40 days, September 24 to November 2, you can visit your local Clerk's office. See page 38 for more information.

### Tips for voters

- **VOTE EARLY**
- **Follow the instructions.**
- **Sign the envelope.**
- **Deliver to your Clerk's Drop Box, deliver in person to the Clerk's office, or mail it no later than October 19. Your ballot must arrive by 8 p.m. on Election Day in your Clerk's office or it will not count.**
- **Only you, a member of your household or a close family relative may return your absentee ballot for you. If you have no one who qualifies, call your Clerk's office.**

## Voting on Election Day, Tuesday, November 3rd

**Polls are open from 7 a.m. to 8 p.m.** Everyone in line at 8 p.m. must be allowed to vote. Go to [VOTE411.org](http://VOTE411.org) to find your polling place and to learn what's on your ballot before you vote.

**You will be asked for ID.** Bring ID, but if you forgot to, you may sign an affidavit attesting to your identity. You will be issued a regular ballot. If the poll worker wants to issue you a provisional ballot, call the Voter Protection Hotline at 866-OUR-VOTE.

**Allow time to wait in line and bring a mask.** You will not be refused your right to vote, but face masks are highly encouraged. Poll workers are required to mask up. Masks and sanitizers are available to all. If you run into a problem – there is help. Call the Election Protection Hotline at 866-OUR-VOTE (866-687-8683), 888-VEY-VOTA (Spanish), 844-418-1682 (Arabic), 888-API-VOTE (Asian/PI).

**Michigan voters who feel uncomfortable voting in person on Election Day** amid the pandemic have options: Vote by mail or drop box with an absentee ballot or vote in your Clerk's office by absentee ballot before Election Day, when crowds are expected to be less. Always check the office hours of your local Clerk.

### QUESTION 1

**HEALTH CARE:** What do you see as the federal government's role in health care? Given the Covid19 pandemic, what are your concerns and plans regarding U.S. health coverage, policies and programs, including Medicare and Medicaid?

As we continue to work through the pandemic, it's never been more critical that Michiganders have access to quality, affordable health care. 



This has created a system that hurts the middle class, exacerbates inequality, eliminates jobs, and fundamentally rigs the economy in favor of the powerful and well-connected. We need an economic policy that focuses on jobs. That means we need a simpler tax policy that stops giving politicians the power to reward big businesses and industries. Finally America's regulatory structure needs to stop punishing small businesses, which serve as the backbone of our economy and provide the best pathway to wealth.

Each election cycle there are vast amounts of money put into the campaigns of two political parties soliciting for votes. Legislation will not change how elections have been run. Money has always been a huge part of the election process and the wealthy will find a way to push their agenda, regardless of what the laws says. We have had systems in place to handle the mail-in process before being attacked and stripped. The election process does not address the concerns of the working class. The only way to combat this type of legislation is for workers to create their own political party that will advance workers' issues

Systemic racism, economic disparity and other social injustices that the working-class faces every day will not be changed by Congress. The disparities and injustices we see in our communities have a direct connection to the economic status of that area. The wealth of this country, that is produced by workers, is given to banks and corporations instead of funding the projects needed to combat systemic racism and economic disparities among other items. Social programs such as Medicare, SSI, and public assistance are being attacked each year. The money is there to provide solutions to the problems of the working class.

Science has revealed different ways to produce sustainable energy without destroying the planet, but decisions are being made based on profit, not humanity. Energy-producing methods such as fracking, are obviously destroying the planet, but more sites are popping up all over the country. Human lives need to be placed in higher regard than the profits to a few wealthy individuals. Protecting our water, air and land means not exploiting them for individual gains. The changes that are needed to protect the laboring population are not going to come just through legislation, but rather a fight from the working class.

The United States was founded on the backs of immigrants and slaves. The economic success seen in this country can be attributed to the labor of immigrant workers who have come here seeking a better life or to escape oppression in their home country. Immigrant workers, like many citizens born in the U.S. simply want to work, contribute to their communities and provide a safe environment for their families. They earn money that they spend, creating more jobs and revenue. The threat of deportation keeps immigrants in a submissive role, threatened to speak up for themselves. I support full, immediate citizenship!

I do support mail in ballots. I believe this is a good solution especially in lieu of the COVID-19 and social distancing. I support reform solutions: HR1 – Democracy Reform which would expand voting rights, overhaul our campaign finance system, end extreme gerrymandering, and do much more to transform our democracy to make it fairer, stronger, and more inclusive. I support automatic voting registration. I also support campaign funding reform that makes it a more equal playing field for the candidates. We need to eliminate Citizens United. Too many politicians only represent special interest groups and not the people.

People of color deserve the same justice and safety as everyone else in this country. Police Officers need to serve and protect all people regardless of the color of their skin. I support expanding the PEACE Act other meaningful police reforms like ending chokeholds, more transparency of complaints against officers, and more involvement from the Attorney General, A person's right to survive an interaction with law enforcement should not be dependent on where they live or the color of their skin. I believe in human rights and equality and will always fight for the rights of all people.

I have already pledged to support the Green New Deal. I believe in the science and data when it comes to the seriousness of climate change. I pledge and am committed to combating climate change. I believe it is a human right to have access to clean water and clean air and a clean environment I will make polluters pay for the damage that they cause to our environment. I will promote clean infrastructure and new technology that can create 1000's of good paying jobs. I strongly disagree with selling off our public land and parks or renting them out for oil and gas profits. These lands belong to the American people.

I believe in finding a compassionate pathway to citizenship. DACA recipients need to be granted their American citizenship. Families need to stay together as they seek U.S. asylum. I do not support inhumane and militarized ICE techniques. Congress needs to address this and move forward to fix our broken immigration process. The same inhumanity we are seeing in local police actions against people of color is similar to what we are seeing in immigration practices and lockups. I do not believe in the "Wall" and will support more funds allocated to our immigration court systems and processing administration.

We should have nationwide Voter ID administered by each state so that we are sure of who is casting each ballot and that they are qualified to do so. I do not support mailing ballots to all eligible voters - eligible voters should have to proactively contact their local clerk or appropriate municipal authority and request an application which if properly filled out and returned should then result in them getting a ballot.

With regard to economic disparity, I believe the ideas outlined above under the Economy section will help to level out everyone's economic opportunity. With regard to systemic racism and other social injustices, the Civil Rights Act and other current protections in place must be enforced by the Judicial branch of the government - we must adhere to our current standards in situations where those standards are not upheld before we consider additional Federal requirements. As a Member of Congress I will speak out against any injustice that violates the Rule of Law.

The US Government has many current energy policies which are designed to protect our water, air, and land. We must be aware of these policies and see that they are enforced in a uniform manner. I also believe that it must also be a high priority for the United States to become more energy self sufficient.

We should support the current laws that are in effect and ensure that people wanting to immigrate to the United States use the processes that have been long established. Our LEGAL immigration system is very reasonable and allows us to continue the tradition that founded our country.

In Congress, I have worked to protect our democracy and secure our elections. I proudly voted for legislation to strengthen voting rights, strengthen the security and integrity of federal elections, and reduce the role of big money in politics. I believe the Citizens United decision should be overturned so we can return power to the American people where it belongs. I voted for the Justice in Policing Act, a bill to improve police accountability and end racial profiling. On the Education & Labor Committee, I have worked to address disparities in our schools, hospitals, workplaces, and environment.

Addressing the threat of climate change is the challenge of our generation, and we need to rejoin the Paris Climate Agreement and reduce carbon emissions in coordination with the rest of the world. As a Member of the Science, Space, and Technology Committee, I have also been a champion of clean energy, sustainable manufacturing, electric vehicle development, and protecting our Great Lakes and other natural resources. I have also introduced a bipartisan bill to develop new technologies to improve our plastics recycling capability, and passed legislation to address the threat of PFAS contamination.

Congress must continue working to fix our broken immigration system by securing our borders and formalizing a path to citizenship for those living, working, and paying taxes in the U.S., and even serving in our military. I oppose proposals that seek to reduce legal immigration, which would lock talented individuals out of our economy. I have supported bipartisan proposals to make it easier for high-skilled immigrants to come here through the employment-based green card system. We also need to ensure consistent, humane practices at our borders that do not separate families.

I will defend the right of everyone to vote, as well as their right to free speech. I oppose taxpayer funding of elections. Taxpayers should not pay politicians to run negative ads. In Michigan, every citizen has the right to vote by mail, but this right must be exercised lawfully. I worry about the Secretary of State engaging in unconstitutional efforts to impact our elections.

There are clearly injustices, and a host of problems and disparities across the country. We need safe communities, good jobs, broad-based quality education, and everyone must be treated equally. Slogans like "defund the police" are reckless and wrong, and they won't solve anything. We need to hold police accountable and ensure they are properly trained. When laws are broken, we need a justice system that punishes people according to their actions, not the color of their skin. Congress is at its best when it defend principals like equal access to justice and liberty.

The decreased demand for U.S. energy and decreases in pollution are moving in the right direction. We are finally shedding our dependence on foreign oil and no longer shipping billions of dollars to the middle east. We must continue to build on that independence and develop new, cleaner ways to produce energy. This is important for our economy. The industrial legacy of dumping toxic chemicals into our air and water is something that we must still work to reverse. Sadly too much tax money that could have been spent on cleaning our world has been spent on lawyers and red-tape.

U.S Immigration policy is completely broken. The politicians play games and exploit the vulnerable. The American people have a clear view: secure the border, treat people decently, send criminals home, and evaluate legal immigrants in a fair and open process. Liberal politicians are part of the broken process. They want 11 million illegal aliens to cut to the front of the line and become citizens. At the same time, they want to shield from punishment illegal aliens who attempt to buy guns. That is nonsensical, and right now we need an immigration policy that makes sense and works for the American people.

We need universal health care coverage in the United States, available to everyone, regardless of income. We currently have system that is more of "sick care" than preventative health care. Big Pharma and health insurance companies continue to have too much influence in our governance system and people continue to suffer. I have voted to strengthen and improve the Affordable Care Act and am a co-sponsor and strong supporter of Medicare for All. We need to defend the Affordable Care Act from Republican attacks while pushing for a Medicare for All system.

### QUESTION 2

**Economy: What federal policies do you support for a healthy economy and to help the broader American public improve their economic positions?**

During the pandemic, I introduced the Automatic Boost to Communities (ABC) Act, which would give every person in the U.S. \$2,000 per month until the end of the crisis and \$1,000 monthly for a year after. I've also introduced the BOOST Act which would allow everyone making below \$100,000 a refundable tax credit for up to \$3,000 per year. This would cut the poverty rate in the U.S. by 45%. We must increase the minimum wage to at least \$15/hr and create equitable public school funding. We must address income inequality and invest in people first. This means our government resourcing communities and not corporations.


Student debt and better outcomes are the most pressing issues. Getting a degree that leads to a successful career is paramount. If you spend \$100,000 on a vehicle, it has a warrantee and good trade-in value. Some universities guarantee tuition rates until graduation. What kind of guarantee comes with an MSU degree? There is an implied contract. If students spend \$100,000 to earn a degree but can't earn enough to repay the cost, they could be allowed free or reduced tuition for more education or placement services. Any student debt payments could be suspended with no additional interest for certain periods.

More online opportunities and out-state satellite locations are needed. That means investment in changes, especially the availability of internet to all students. Some great outreach has been ongoing since 1915 with MSU Extension service. They help grow the economy in nearly every county, educating at the community and individual level. In 2017 their programs reached 360,000 kids and adults, and their Product Center helped launch 91 new businesses. The MSU Extension program should be supported and expanded.

## Women's Suffrage and the League of Women Voters

The League of Women Voters was founded in 1920 by suffragists as a “mighty political experiment” designed to help 20 million women carry out their new responsibilities as voters. The suffragists had worked for more than 70 years for women’s right to vote, and on August 26, 1920, the 19th amendment was officially ratified.

“We celebrate this great achievement with recognition that women’s suffrage was not perfect,” writes Virginia Kase, CEO of the League of Women Voters. Not all women gained equal access at the ballot box. Women of color, especially those in the south, did not have full voting rights.

“Progress towards a more perfect democracy is often messy, but we can’t allow the ends to justify the means, especially if it perpetuates oppression. Let us use the lessons of our history to inform our present and our future. Let us seek out ways to ensure all eligible voters have their voices heard and their votes counted.”

# HOW CAN I REGISTER TO VOTE IF...?

## ...I don't have photo ID?

Provide a current utility bill, bank statement, paycheck, government check, or other government document to prove your identity and residency. Electronic proof is acceptable

## ...I'm a student?


You can register to vote at your school address or your home address, depending on what address you consider your residence.

Michigan requires your voter address and license/state ID address to match. If you already have a Michigan ID and you register to vote at a different address, you will receive a change of address sticker to affix to your license/ID.

## ...I am incarcerated or have been convicted of a crime?

Only persons who are currently incarcerated and serving a sentence for a misdemeanor or felony conviction are prohibited from voting.

You can register and vote if you are on probation or parole. Your right to vote is automatically restored when you are released, but please update your address.



## ...I am homeless?

You don't need a home address to register to vote, but you do need to identify an address for mail, and a location you consider a place of residence; it can be a street corner, a park, a shelter or any other place where you usually stay.

## ...I am in the Military?

If you're out of state in the military, your last Michigan voter registration is still valid. For more information, visit the Federal Voting Assistance Program at [www.fvap.gov/](http://www.fvap.gov/)

## ...I moved?

- If you moved to a new city or township, you must re-register. If you move within a city or township and are already registered to vote, you only need to update your address.
- If you are in jail, awaiting arraignment or trial, you may register to vote. If you are in jail after being convicted and sentenced, you may not register to vote or vote while you are confined.

I am seeking re-election to the Michigan Supreme Court to continue advocating for the principle that everyone, regardless of their ability to afford a lawyer, deserves equal access to justice and a fair opportunity to have their case heard. Since joining the court in 2013, I have worked each day to ensure that our courts are accessible, independent, efficient, and engaged with their communities. I spent my career as a lawyer working for individuals who were disenfranchised from our justice system and prior to being elected was the Associate Dean for Clinical Affairs at the U of M law school, where I still teach today.

Every process can be improved, including the one we use to elect justices in Michigan. It is important that the court is nonpartisan and therefore, in my view, the party nomination process along with some of the independent expenditures can send the wrong message to the public. Judges and justices have to be willing to lose friends and elections when making decisions—that’s what their oath requires and in my experience they are, which makes some of the cost to public confidence regrettable. However, this is the process the People of Michigan have selected and I welcome their assessment of my work at the ballot box.

The most critical challenge is access to justice. Eight of 10 people in Michigan can’t afford a lawyer when they have a civil legal problem and they have to either navigate the courts without one or they simply don’t even try. We announced a Justice For All Taskforce last year which aims to achieve 100 percent access to the civil justice system in Michigan. There is also an absence of innovation and technology in courts, which costs them transparency, efficiency and access. We have made great progress recently, but we need to make processes more user-friendly and efficient to improve our service to the public.

The Supreme Court needs Justices who will apply the law as written, not as it ought to be written in the mind of the Judge. My background in the law for over forty years has taught me the importance of this purpose. My experience in the practice of law before judges has taught me that judges are sometimes reluctant to simply apply the law as written. I can bring a balanced respect for the written law and the Constitution in particular to the bench, so that Justice may be done.

The nomination and election process for Supreme Court Justices is adequate. Campaigns will always be funded in part by special interest and those who propose schemes to limit the effect of those interests, have an interest of their own in influencing the outcome of elections. The People are the best check on those interests and funding abuses through the ballot box. Government “solutions” and the snake oil of “bipartisan” support are designed to simply increase major party control of the Supreme Court and should be avoided.

The future of the judicial system is for the People to decide, but that future must recover a solid commitment to the rule of law, not the law of judges. Michigan Lawyers must also be freed from the politicized State Bar of Michigan by elimination of compulsory membership. The Supreme Court should be leading this fight. Instead, it sides with the Bar. It compels lawyers to pay money to the Bar for the propagation of ideas with which they disagree. The Court also tramples down the natural rights of conscience in the process. Securing natural rights is the states only compelling interest.

As an unexpected candidate in almost every way; I am running for the ability to affect positive change across Michigan for generations. Bringing my unique world view to the Courts. My secondary goal in running is to bring awareness to the fact that in Michigan’s 183 years as a state we are only beginning to bring Indigenous people into the fold. I wonder how many Indigenous clerks there are across Michigan. I wonder how many Indigenous lawyers have the opportunity to take a job offering various opportunities instead of working blue collar jobs through school like I did. These aims are why I am running.

Although I believe money and politics should not intertwine, my only comment on Campaign Finance is that current Michigan law makes things appear as if those in power never considered that an Indigenous person would ever get as far as being on the ballot. And, justifiably, it has taken 183 years for Michigan to have their first ever Indigenous person Candidate for Supreme Court Justice. There are specific barriers to me, as a candidate, because of my race that are built into Michigan Law. Neighbors & sister tribes are restricted, for reference please see MCL 169.252, and MCL 169.254.

First, Michigan needs to reduce archaic laws. Just because the constitution overrules certain laws does not mean that Michigan should have these laws on the books. Next, Michigan has gotten too close to the “debtor’s prisons” of time long past. Our Founding Fathers set up a system so that we would never need to put people in jail for not being able to pay a bill. In Michigan numerous people are in jail for this very reason. This systemic problem influences society in many ways. The less able you are to pay a fine, the more likely that you have a criminal record because of debt owed to the state. This is unacceptable.

The Rule of Law is a bedrock of our society, and we must be vigilant in protecting it. Justice, due process, equity, and fairness all flow from the Rule of Law. As a Michigan Court of Appeals Judge, I am committed to upholding these principles. Before becoming a judge, I worked in the Legislature as House General Counsel, in 3 federal courts as a law clerk, and as a lawyer in private practice (e.g., antitrust, employment, healthcare, criminal law, etc). I've given back to my community through my church and alumni association, as well as teaching at the MSU Law School and serving on a national judicial education board.

The people should decide who their judges are. There are many ways this can be done, and Michigan's system strikes a reasonable balance. It is absolutely essential that judges run as nonpartisans, because our judicial canons require us to "be unswayed by partisan interests." Canon 3(A)(1). We need more outlets to inform the public about each candidate's judicial philosophy and experience, so that judicial elections are focused on the issues, not catchy slogans or memorable phrases. And, most importantly, candidates must be transparent—that is why I have posted my opinions to my website, BrockForJustice.com.

We have the greatest legal system in the world—if you can afford it. Simply put, justice that is too expensive is not justice. We must make access to justice cheaper for everyone, from the single mom to the corner store-keeper to the adoptive parents to the low-income juvenile to our biggest employers. So, (1) the Michigan Supreme Court needs to reform its court rules to make pretrial matters (e.g., fact discovery, motion practice) quicker and cheaper, and (2) the Court needs to work with the Legislature and other groups to provide juveniles who enter the justice system with early and effective intervention.

My experience with employment law (representing small businesses, nonprofits, and individuals); bi-partisan advocacy for public schools, voting rights, and conservation; criminal law and abuse/neglect cases; and community mediation will add value to the Court. I have served in leadership roles on my local school board, in nonprofit organizations, and on foundations working to solve deep challenges in our communities. We need justices with broad backgrounds and exposure to different viewpoints to make important decisions and ensure the Judicial Branch functions fairly and transparently to assure public trust.

Our partisan nomination process is confusing. An alternative is a non-partisan commission/appointment by Governor/retention election process. Importantly all judges should face voters in elections to ensure they stay connected to those served. Voter guides with candidate information could be sent to all voters with absentee ballots and be placed in polling places. Finally, we must have full, timely disclosure of all money spent in judicial races. Candidates already have robust campaign finance disclosure requirements, but the law should also require full disclosure of money spent by everyone else.

The lack of complete data makes it impossible to fully study and understand outcomes in our criminal justice system. The Court should work to modernize technology platforms in order to gather data in a usable format across the State so that outcomes are examined to ensure justice is delivered fairly across all demographics and programs are implemented that ensure safer communities. Additionally, we have a crisis in our court system; the vast majority of litigants lack access to counsel. We must utilize technology and new pathways to ensure everyone can access justice fairly (even if unrepresented).



## Statewide Proposals on November 3, 2020 Ballot



### Statewide Proposal 20-1 Michigan Use of State and Local Park Funds Amendment

**A proposed constitutional amendment to allow money from oil and gas mining on state-owned lands to continue to be collected in state funds for land protection and creation and maintenance of parks, nature areas, and public recreation facilities; and to describe how money in those state funds can be spent.**

[Referred to the Ballot by the Legislature]

#### ***This proposal would:***

- Allow the State Parks Endowment Fund to continue receiving money from sales of oil and gas from state-owned lands to improve, maintain and purchase land for State parks, and for Fund administration, until its balance reaches \$800,000,000.
- Require subsequent oil and gas revenue from state-owned lands to go into the Natural Resources Trust Fund.
- Require at least 20% of Endowment Fund annual spending go toward State park improvement.
- Require at least 25% of Trust Fund annual spending go toward parks and public recreation areas and at least 25% toward land conservation.

#### **Should this proposal be adopted?**

# Frequently Asked Questions

MichiganVoting.org - Michigan Election Protection Coalition

## What if I want to vote before Election Day, but have not requested an absentee ballot yet?

Visit your city/township clerk's office as soon as possible, fill out an application for an absentee ballot, and submit it to the staff. Complete the ballot while you're in the office, place it in the envelope provided, sign the outside of the envelope with your official signature, and submit it to the staff.

## What if I requested an absentee ballot but never received it?

Prior to Election Day, visit your city/township clerk's office as soon as possible to cancel your first absentee ballot and request a new one. The deadline to do this is Monday, November 2, 2020 by 4 p.m.

On Election Day, you can go to your polling place, complete a simple form indicating you never received your absentee ballot and vote.

## What if I received my absentee ballot, but then made a mistake on it, I lost it, or it was destroyed?

Visit your city/township clerk's office as soon as possible to cancel your first absentee ballot and request a new one. If you still have the absentee ballot, because you made a mistake or it was only partially destroyed, take it with you. The deadline to do this is Monday, November 2, 2020 by 4 p.m.

Or you can go to your polling place on Election Day, fill out a form and vote. If you have the absentee ballot, because you made a mistake or it was only partially destroyed, take it with you.

## What if I have my absentee ballot, but I don't have enough time to mail it back to my clerk?

Your absentee ballot must be RECEIVED by your city/township clerk by 8 p.m. on November 3, 2020 to be counted. To be sure it arrives on time, you should bring your completed absentee ballot to your city/township clerk's office or deposit it into a drop box provided by your clerk.

You can call or email your city/township clerk to find out whether they have a drop box. To find your city/township clerk's contact info, you can visit [www.mi.gov/vote](http://www.mi.gov/vote).

## What if I have my absentee ballot but decide to vote in person on Election Day?

If you decided not to vote by absentee ballot, take your absentee ballot to your polling place on Election Day and surrender it. You will then be issued a new ballot that you can vote in the polling location.

## What if I mailed my absentee ballot to my city/township clerk, but I am concerned that it won't arrive in time?

You can track your absentee ballot at the Michigan Voter Information Center - [www.mi.gov/vote](http://www.mi.gov/vote) - to see if your clerk has received it. If your absentee ballot has not been marked as "received," visit your clerk's office, ask to spoil your original absentee ballot, and request a new ballot. The deadline to do this is Monday, November 2, 2020 by 4 p.m.

## Where is my city/township clerk's office, and when is it open?

# Know Your Voting Rights

## What if I registered to vote but I'm not on the voter list at my polling place?

If you have the receipt you received when you registered to vote, show it to the poll worker and then vote.

If you don't have your receipt, give the poll worker your address and ask if you're at the correct polling place. If you are not at the right polling place for your address, go to the correct polling place.

If you are at the correct polling place but are not on the voter list, you can go to your city/township clerk's office with proof of residency and register to vote before 8 p.m. on Election Day. While at the clerk's office, you can vote by absentee ballot.

If you cannot go to the clerk's office with proof of residency, you may be able to cast a "provisional ballot." To do this, you'll have to swear you believe you previously registered to vote.

If you can provide a photo ID that shows your current address in that polling place, your provisional ballot will go into the machine and be counted on Election Day. If not, it will go into an envelope, and the clerk will review it after Election Day. If your ballot goes into the envelope, you have six days after Election Day to go to the clerk's office with any documentation to show that you are registered to vote.

## What if I go to the wrong polling place?

Go to the correct polling place by looking it up online at the Michigan Voter Information Center [www.mi.gov/vote](http://www.mi.gov/vote), by calling the nonpartisan Election Protection hotlines at the end of this guide, or by calling your city/township clerk before you go vote. If you arrive at the wrong polling place, ask a poll worker to help you find your correct polling place. If you aren't registered to vote where you currently live, go to your city/township clerk's office with proof of residency before 8 p.m. on Election Day to register to vote.

## What if I have a problem voting, or someone is trying to intimidate or harass me?

Tell a poll worker immediately. If the poll worker is the problem, or they don't address the problem, call your local city/township clerk. If the city/township clerk doesn't address the problem, call one of the nonpartisan Election Protection hotlines at the end of this guide.

## What if someone challenges my right to vote?

**Step 1:** Ask to be sworn in by the poll worker,

**Step 2:** Answer whatever questions are necessary to establish your eligibility to vote, and,

**Step 3:** Vote.

## What if I make a mistake on my ballot or the voting machine malfunctions?

If you make a mistake, ask for a new ballot right away. You have the right to a new ballot if you catch the mistake before your ballot is inserted into the tabulator machine and counted.

If the scanner rejects your ballot, ask for a new one. You have the right to start over.

If the tabulator machine isn't working, you can place your completed ballot into a bin in the tabulator machine. The poll workers will insert your ballot into the tabulator once the machine is working again.

## DID YOU KNOW?

**Citizens may register to vote right up to and including Election Day. Beginning on October 20 through Election Day at 8 pm you must register in person in your Clerk's office.**

**You can register to vote online at [www.Michigan.gov/vote](http://www.Michigan.gov/vote) until October 19? (You cannot vote online.)**

**ALL registered voters can vote from home or in their local Clerk's office by absentee ballot after September 24.**

### VOTER REGISTRATION

Online at [www.Michigan.gov/vote](http://www.Michigan.gov/vote) before October 20 (do not wait)

By mail - Complete a voter registration application and mail it to your local Clerk by October 20 or sooner.

In person – First call your local or county clerk's office or Secretary of State branch office. Find your clerk [www.Michigan.gov/vote](http://www.Michigan.gov/vote).

When applying for services at state agencies that provide public assistance (such as Medicaid, WIC and food stamps) or services to people with disabilities.

**Am I already registered?** You can check at [www.Michigan.gov/vote](http://www.Michigan.gov/vote)

#### You can register to vote if:

- You are a U.S. citizen, are or will be a resident of Michigan and the city or township where you want to register to vote for at least 30 days by Election Day,
- You are at least 18 years old on or by Election Day, and
- You are not incarcerated on Election Day (see below for exceptions).

#### What if I'm a student?

- You can register to vote at your school address or your home address, depending on what address you consider your residence.
- Michigan requires your voter address and license/state ID address to match. If you already have a Michigan ID and you register to vote at a different address, you will receive a change of address sticker to affix to your license/ID.

#### What if I am incarcerated or have been convicted of a crime?

- Only persons who are currently incarcerated and serving a sentence for a misdemeanor or felony conviction are prohibited from voting.
- You can register and vote if you are on probation or parole.
- Your right to vote is automatically restored when you are released, but please update your address.

#### What about someone who is homeless?

You don't need a home address to register, but you do need to identify an address for mail, and a location you consider a place of residence; it can be a street corner, a park, a shelter or any other place where you usually stay.

## ABSENTEE BALLOTS –

**NO REASON NEEDED:** Go online to [www.Michigan.gov/vote](http://www.Michigan.gov/vote) or request an application from your local Clerk.

**IN PERSON:** Apply, vote the absentee ballot in your Clerk office and submit in person OR take the ballot home, mark the ballot, and drop it off at the Clerk office or your Clerk’s Drop Box. Or Mail it back (1st class postage required) by October 19.

► After September 24, a person who can provide proof of residency may register to vote, get an absentee ballot, and vote all in the same visit to their local Clerk’s office.

**BY MAIL/VOTE AT HOME:** Vote the absentee ballot at your convenience and use the provided envelope to mail (1st class postage required). Your ballot must be received in your Clerk’s office by 8 pm on Election Day to be counted. After October 19, use a drop box or deliver in person.

### FOLLOW ALL INSTRUCTIONS - SIGN THE RETURN ENVELOPE.

Your signature will be checked and matched.

► Only a member of your household or a close family relative may return your absentee ballot for you. If you have no one who qualifies, call your Clerk office.

### IN PERSON VOTING

**Photo ID** - Michigan requires poll workers to ask for photo ID. If you don’t have it with you, you may sign an affidavit attesting to your missing photo ID and your identity, and a regular ballot will be issued to you.

- You may bring someone with you to help (translate, read, etc.), if he/she is not your employer, an agent of your employer, or an officer/agent of your union.
- Every location MUST have a Voter Assist Terminal (VAT) that has several options to help you vote.
- If you have a concern about accessibility on Election Day, you should contact your Clerk office prior to that day; in some instances, you may qualify for curbside voting.


